Directions to Lake Sonoma Staging Area:

From the North:

101 south to Dry Creek Exit, Turn right on Dry Creek Rd. Continue on Dry Creek Rd. into Lake Sonoma Recreation Area, Continue Past Visitors Center then go over Lake Sonoma Dam. Road becomes Rockpile Rd continue on Rockpile Rd.. until you see the sign for Lone Pine parking area. If you are camping overnight, you will turn into the camping area ¼ mile before day use parking area, look for signs.

From the South:

Hwy 10 to the Dry Creek Exit turn left at bottom of exit, go under freeway, and continue on Dry Creek Rd. See above for directions from here.
