TERRAIN: The Ride will be held in oak-studded, rolling hills on access dirt roads and cattle trails. Trail length with obstacles will be 3-4 hours. This is **NOT** a timed event, so you can take your time and enjoy the scenery. This is a Conservation Area; consequently, there will be natural wild life and cattle.

DIRECTIONS: From Merced [@ Hwy 99] take Hwy 140 [Yosemite Exit] east towards Yosemite/Mariposa. Take Hwy 140 to Yaqui Gulch Rd. and turn right to Old Highway. Turn left on Old Highway to the Mariposa Ranch [4333 Old Hwy]. Note: Follow the signs. From Mariposa take Hwy 140 to Yaqui Gulch and turn left. Follow the above directions for Yaqui Gulch.

NOTE: Sign-ups start at 9:00 A.M.; first riders out at approximately 10:00 A.M.
