The Northern Regions Spring Gathering Trail Trial & Poker Ride is a two day state benefit for the California State Horsemen's Association. This two day event includes two (2) double point Trail Trial competitions, two (2) poker hands, catered breakfasts (Sat. & Sun.), a catered dinner (Sat. night) and a jackpot obstacle class (Sat. afternoon), plus lots more.

- 1 The first Trail Trial begins Saturday morning after breakfast. Your trail trial entry includes one poker hand.
- 2 The second trail trial is Sunday morning after breakfast. A poker hand is included.
- 3 If you do not wish to compete in the trail trial but want to ride the trail you can register as a companion / poker ride only rider.
- 4 Jackpot Obstacle Class is a class held after the Trail Trial on Saturday afternoon. This is a Jackpot obstacle. Pay out to first through third places after a 50/50 split with the event.

A package deal is offered that includes the 2 trail trial rides, 2 poker hands, the catered breakfasts and the catered dinner. The cost of this package is \$ 85.00 if purchased before 5/22/07. After 5/22/07 the cost is \$ 95.00.

One day riders are welcome. See entry form for itemized fees.

Non riders, friends and family members are welcome to purchase meal tickets and pokers hands.

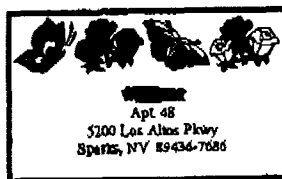

This agreement is binding upon my executors, heirs and assigns.

I expressly waive any right I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affected his settlement with the debtor."

I agree that I will indemnify and hold harmless C.S.H.A. and/or I.V.R. & R.C., their officers, directors, members and agents against all claims, demands and cause of action, including court costs and actual attorney fees, arising from any proceedings or lawsuits brought by or prosecuted for my benefit, in which the release is upheld.

C.S.H.A. and/or I.V.R. & R.C., its agents, or employees shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to my person, horse, or property.
