

A CSHA Trail Trial is approximately a 2-4-hour trail ride with 8-10 Judged natural obstacles along the way.

Obstacles can be natural landscape like creek crossings, uphill, downhill, over logs, etc. Ride safer and with more confidence. (Not a scare fest)

Saturday February 19th we will train on the obstacles and how to best negotiate them.

We will break from 11:30 – 1:00 on Saturday for Lunch

Sunday February 20th we will do Full Trail Trial with Obstacles, Prizes, and competition. Sunday's ride is 3-4 miles. Prizes to 6th place in all divisions

I hereby release the California State Horsemen’s Association herein after referred to as “CSHA” and Riverside Rancheros, Murray Ranch, from all liability for any act of negligence or want of ordinary care on the part of CSHA and RIVERSIDE RANCHEROS. In consideration of my participation in events organized or sponsored by CSHA and RIVERSIDE RANCHEROS I waive, release and discharge CSHA, RIVERSIDE RANCHEROS, Murray Ranch and their directors, officers, agents and members, their representatives, heirs, executors and assigns from any all claims of liability for injury or damage to myself, my animals or my property arising out of my participation. This agreement is binding upon my executors, heirs and assigns.

I expressly waive any rights I may have under California Civil Code 542, which states “ A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affected his settlement with the debtor.

I agree that I will indemnify and hold harmless CSHA, Riverside Rancheros, Murray ranch, and their officers, directors, members and agents against all claims, demands, and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

CSHA and RIVERSIDE RANCHEROS and its agents or employees shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to person, horse or property.
