Directions to be read by obstacle judge to competitor:

Novice/Intermediate: You are stopping for the lunch and relaxation with friends.

point Dismount and tie your horse safely to a tree with a quick release knot. Walk over to the picnic table and read the note to the judge. You are done at this point. Lead your horse out of the obstacle area and continue your ride. Begin when ready.

Advanced: You are stopping for the lunch and relaxation with friends. Dismount and show me your hobble equipment, then wait for further instructions. BEGIN LOWER READY

Tie your horse safely to a tree with a quick release knot. Walk over to the picnic table and read the note to the judge. You are done at this point. Lead your horse out of the obstacle area and continue your ride. Begin when ready.
