

**From Sacramento:** Hwy 99 North to Durham Pentz Rd. Exit right onto Durham Pentz Rd to 4 way stop at Clark Road. Turn right on Clark Rd (Hwy 191) Follow Clark Rd. to Camelot Entrance on the right

**From Marysville or Oroville:** Hwy 70 North to Hwy 191 (Clark Rd) left on Hwy 191 to Camelot Entrance on the left.
