I acknowledge that horseback riding is a sport, which carries inherent risks of injury and damage to myself, my horse, and property. I knowingly assume all risks, whether known or unknown, of horseback riding.

I hereby release the CALIFORNIA STATE HORSEMEN'S ASSOCIATION herein after referred to as "CSHA" and "Northern Park & Recreation District" herein after referred to as "NPRD" from all liability for any act of negligence or want of ordinary care of the part of CSHA and NPRD. In consideration of my participation in events organized or sponsored by CSHA and NPRD, I wave, release and discharge CSHA, NPRD, and their directors, officers, agents and members, their representatives, heirs, executors and assigns from any and all claims of liability for injury or damage to myself, my animals or my property arising out of my participation. This agreement is binding upon my executors, heirs and assigns.

I expressly waive any right I may have under California Civil Code 542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affected his settlement with the debtor."

I agree that I will indemnify and hold harmless CSHA, NPRD and their officers, directors, members and agents against all claims, demands and causes of action, including court costs and actual attorney fees arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

CSHA and NPRD and its agent or employees shall not be liable for any damage which may accrue from any cause or as result of fire, theft, running away, state of health, injury to person, horse or property.
