- **Terrain:** Rock-N-Oak is a beautiful facility with moderate terrain and great views. Horse's should be shod or have boots. Saturday's ride is the longer trail with about 5 to 6 miles and 10 obstacles. Sunday's ride is a shorter ride about 3-4 miles with 8 obstacles.
- **Camping/haul-in fee** \$15.00 per person/day payable to Rock-N-Oak the day of the event. If arriving before Friday or staying after Sunday, or to reserve pens, please contact Rock-N-Oak at 530-424-8108.
- **Raffle** on Sunday after the ride.
- **Gathering** Saturday night around the camp fires bring your dinner and a chair. Sorry no potluck this year due to COVID restrictions.
