- Absolutely no campfires. Dogs on leash. Smoking only in your own trailer.
- If you can, please bring your checkbook and we can adjust entries as needed on site. If your check has already been deposited we will put in for reimbursement as necessary.

Follow SR 120 past Groveland to Cherry Lake Rd. Turn left of Cherry Lake Rd just past the bridge; follow TT signs to 12850 Cherry Lake Rd.

From the north

Hwy 99 to SR-120 towards Yosemite National Park. Follow SR 120 past Groveland to Cherry Lake Rd. **DO**

**NOT TAKE OLD PRIEST GRADE ROAD**

Follow SR 120 past Groveland to Cherry Lake Rd. Turn left of Cherry Lake Rd just past the bridge; follow TT signs to 12850 Cherry Lake Rd.
